

An Eavesdropping Threat Detection Sweep can be done in approximately 6-8 hours if the site is large, more time will be required. The hard line telephones are checked, a physical search is done and a radio frequency analysis is done for hidden wireless microphones and video cameras.

Our standard TSCM sweep services include the following:



Inspect all outlets, switches, and lighting for VLF/RF devices. Inspect all PBX, LAN, and WAN connections and equipment. Inspect all tables, chairs, desks, cabinets and furniture.

Analysis of all EMF emanations. (0-8GHZ)

Analysis of Infra-red and Laser emanations.

Active and passive light spectra examined.

Evaluation of computer network and associated cabling. Inspection of all Xerox, fax, and other imaging equipment.

Phone lines inspected and toned back to the telecom room.

Thermal imaging and analysis of inspected areas.

Most activities will overlap to provide complete coverage.

Motor Vehicle TSCM Sweep



A standard "Motor Vehicle" will require 2-4 hours.

A TSCM/Tracking inspection performed on a standard, non-luxury motor vehicle will require two to four per vehicle (depending on the vehicle).

Examinations of luxury vehicles, larger SUVs, motor coaches, boats, and similar motor vehicles will usually involve several days at a higher cost.

Residential TSCM Sweeps
